Launching of the ASEAN Drug Monitoring Report 2024



The ASEAN Drug Monitoring Report 2024 was launched on 26 August 2025 at the 46th ASEAN Senior Officials Meeting on Drug Matters (ASOD) hosted by the Central Narcotics Bureau (CNB) of Singapore. The launching of the Report was presided over by H.E. Mr. K. Shanmugam, Minister of Home Affairs of Singapore and was attended by the heads of national narcotics control agencies of ASEAN Member States and representative of ASEAN Secretariat.

The ASEAN Drug Monitoring Report 2024 is the tenth publication of the ASEAN Drug Monitoring Network (ADMN) since the first formulation of the ASEAN Drug Monitoring Report 2015 that had been launched in 2016 on 26 August 2016 at the press conference of the 37th ASEAN Senior Officials Meeting on Drug Matters (ASOD) hosted by the Office of the Narcotics Control Board on 24-26 August 2016 in Bangkok, Thailand. This means that the ASEAN Drug Monitoring Network has been firmly established for 10 years as the core programme of ASEAN-NARCO on data collection and sharing for drug control as an information collection instrument developed for all ASEAN Member States' utilization to monitor drug situation and early warning on drug situation through the formulation of the ASEAN Drug Monitoring Reports which have been continuously formulated annually with the joint cooperation of ASEAN Member States through the joint efforts of their ASEAN Drug Monitoring Network Team of each ASEAN Member State.

The ASEAN Drug Monitoring Report has the uniqueness for the information contained in the report and for the formulation of the report which derived from the joint cooperation of ASEAN Member States. The information was given by national narcotics control focal points of ASEAN Member States which was the open information that ASEAN Member States would like to share among ASEAN Member States and to the world community to learn drug situation of ASEAN region that had affected to the world drug situation. The ASEAN Drug Monitoring Report reflected the situation of drug abuse, such as drug treatment, seizure reports, major drugs of abuse, precursors and chemicals situation as well as the sharing of information on research innovation, policy and drug control programme implementation operated by ASEAN Member States.

The content of ASEAN Drug Monitoring Report comprises of 5 Chapters and Annex:

- Chapter 1 : Overview of ASEAN drug trends and patterns
- Chapter 2 : Analysis of major drugs problem in ASEAN
- Chapter 3 : Country drug situation by ASEAN Member States
- Chapter 4 : Research knowledge and innovation by ASEAN Member States
