Executive Director of UNODC emphasized that health and safety should depend on reliable information. "Using the World Drug Report and its data as a basis".

On 26 June 2021, Ms. Ghada Waly, Executive Director of UNODC delivered statement reiterating that health and safety depended on reliable information. She highlighted the need for evidence-based approaches to equip the public as well as health providers and decision makers with tools to inform choices and effective services. "We need to fill gaps in trusted public information with greater investments in health, science, and data," she said. "Governments need to expand evidence-based prevention and treatment programmed as well as monitoring and early warning mechanisms to help lower-income countries detect and counter new substances and use trends."
